- * Carriage of above mentioned items will be considered as noncompliance and appropriate enforcement action including penal action under section 10 of the Aircraft Act, 1934 will be initiated against the erring passenger which may extend to two years of imprisonment and shall also be liable to fine up to ten lakhs rupees.
